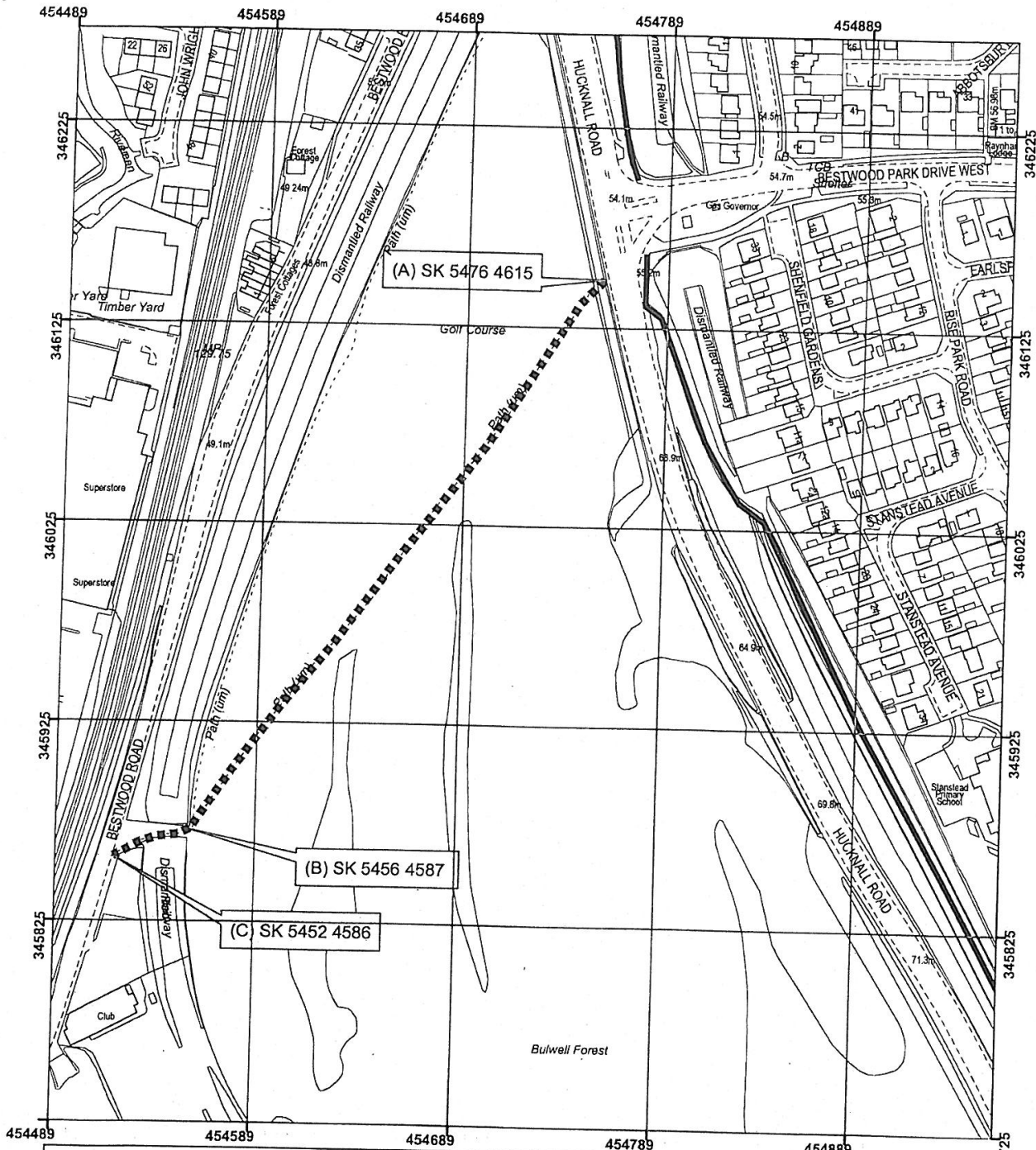

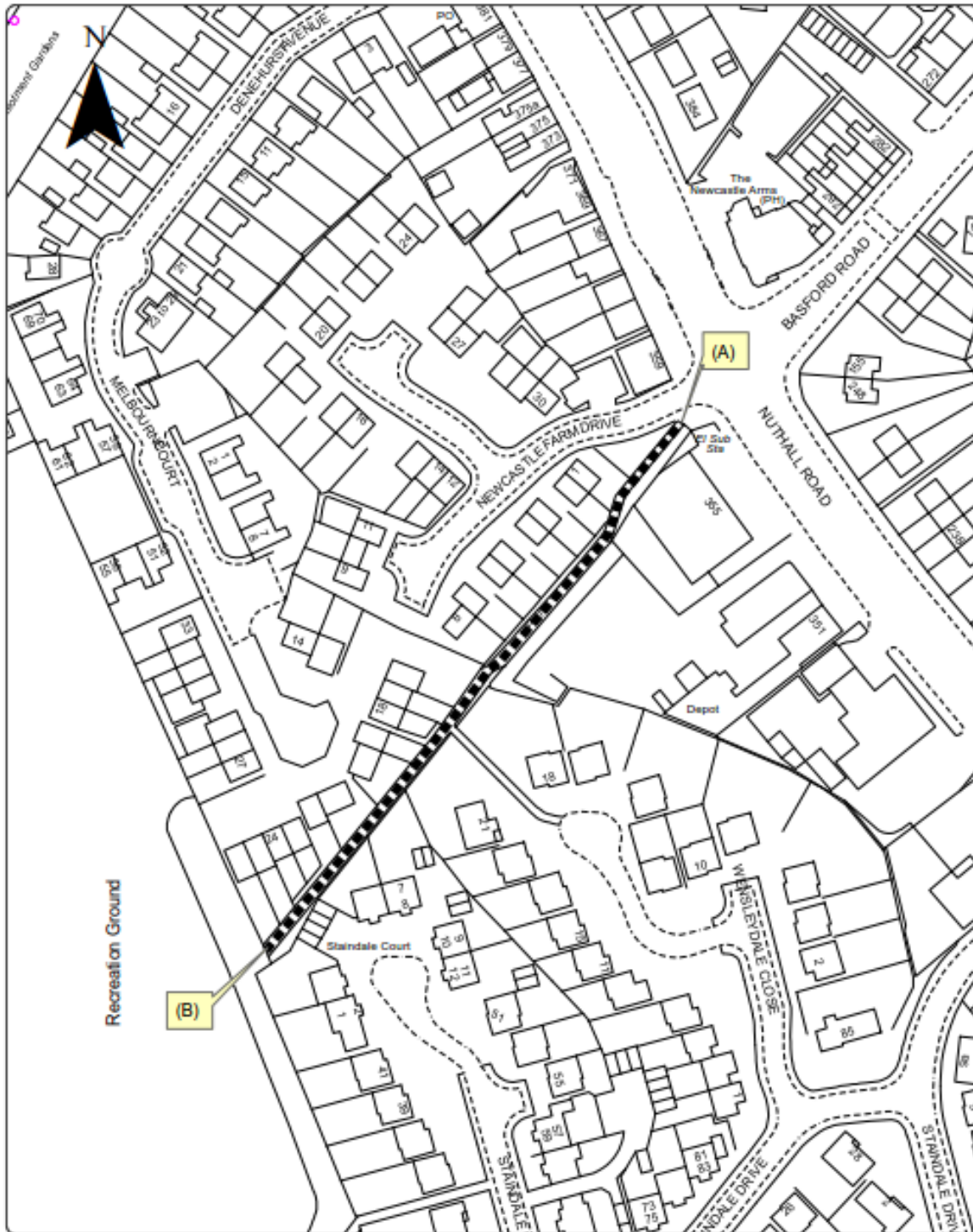


User Evidence for Claimed Public Right of Way at Broad Marsh Centre

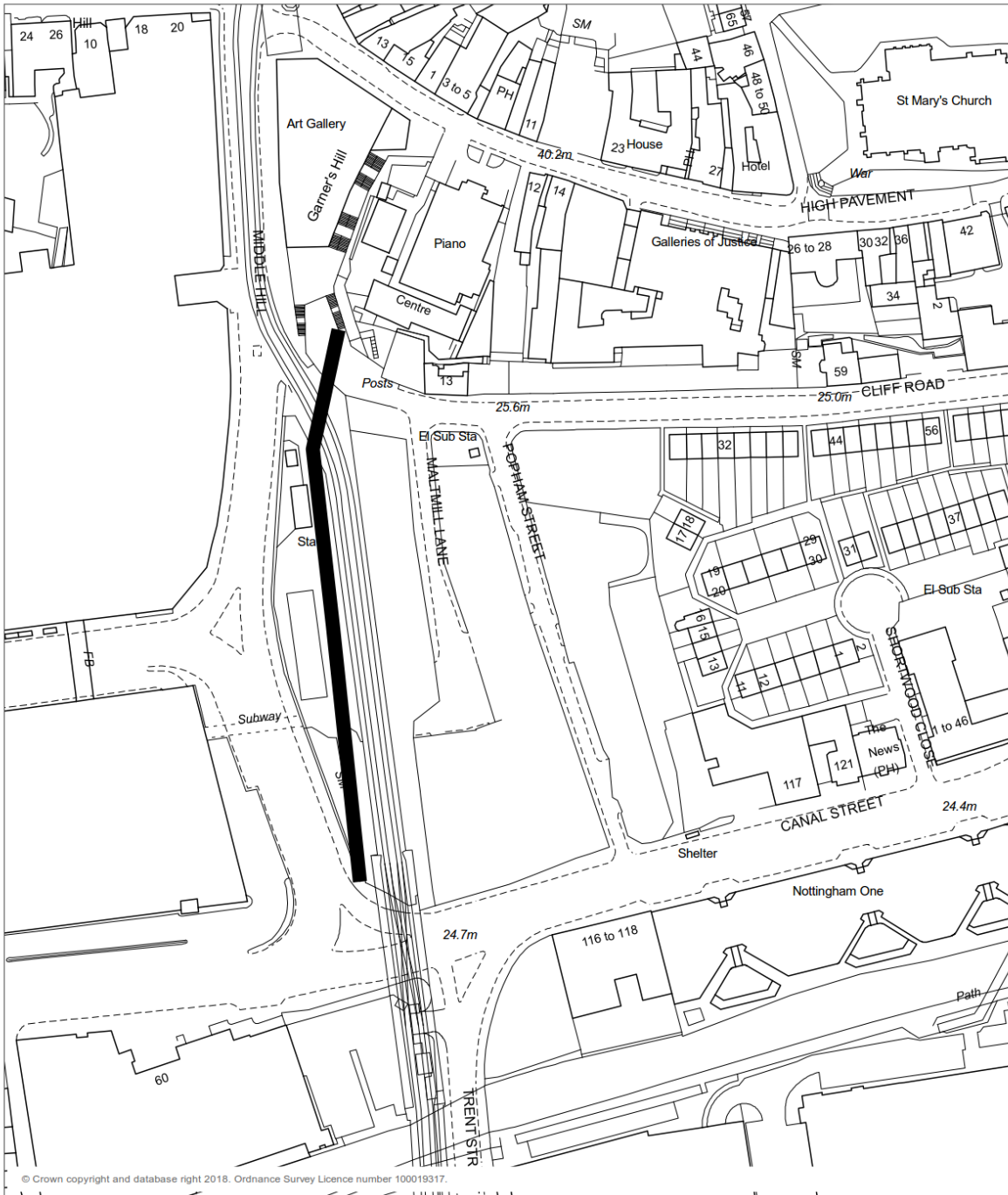

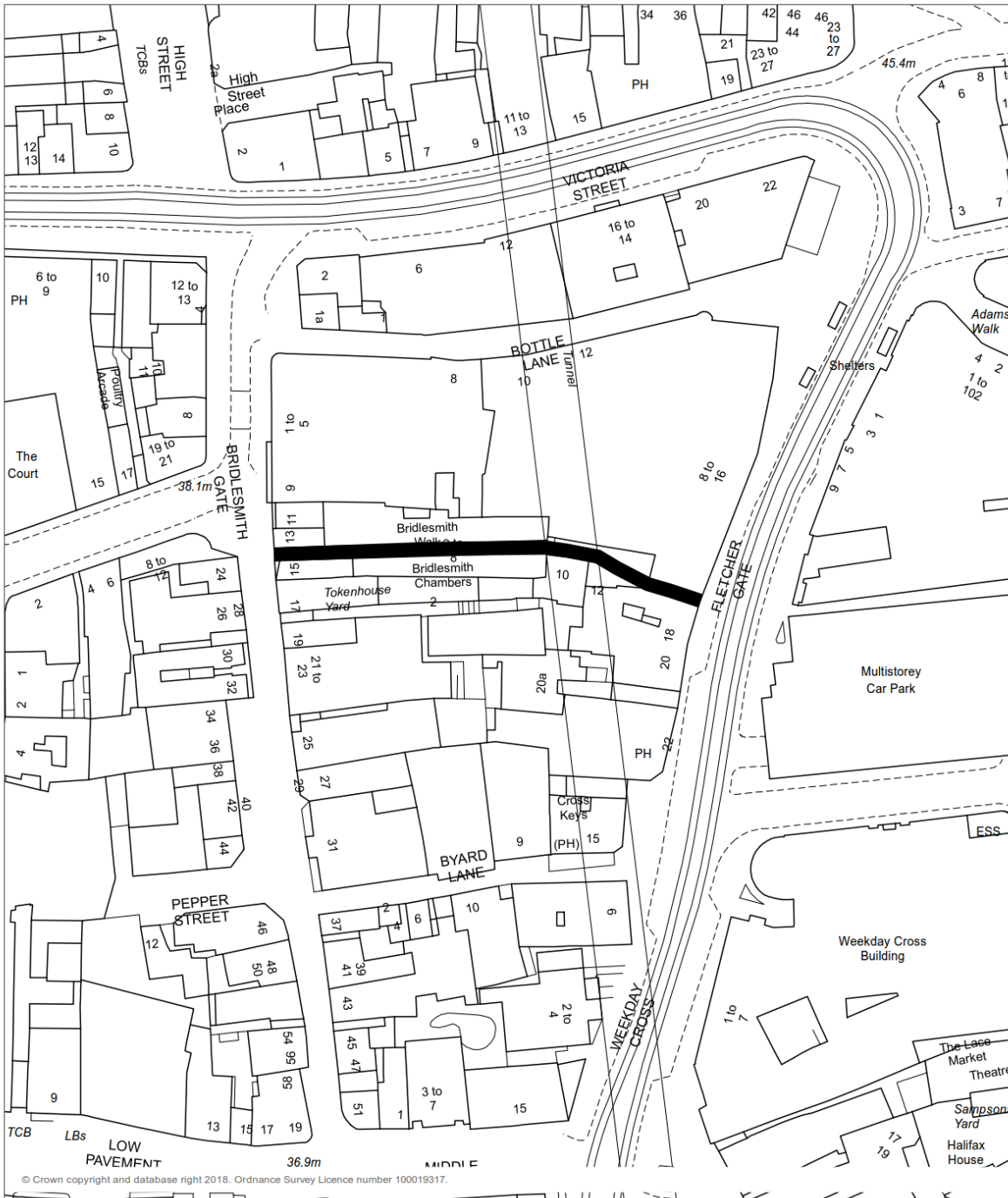

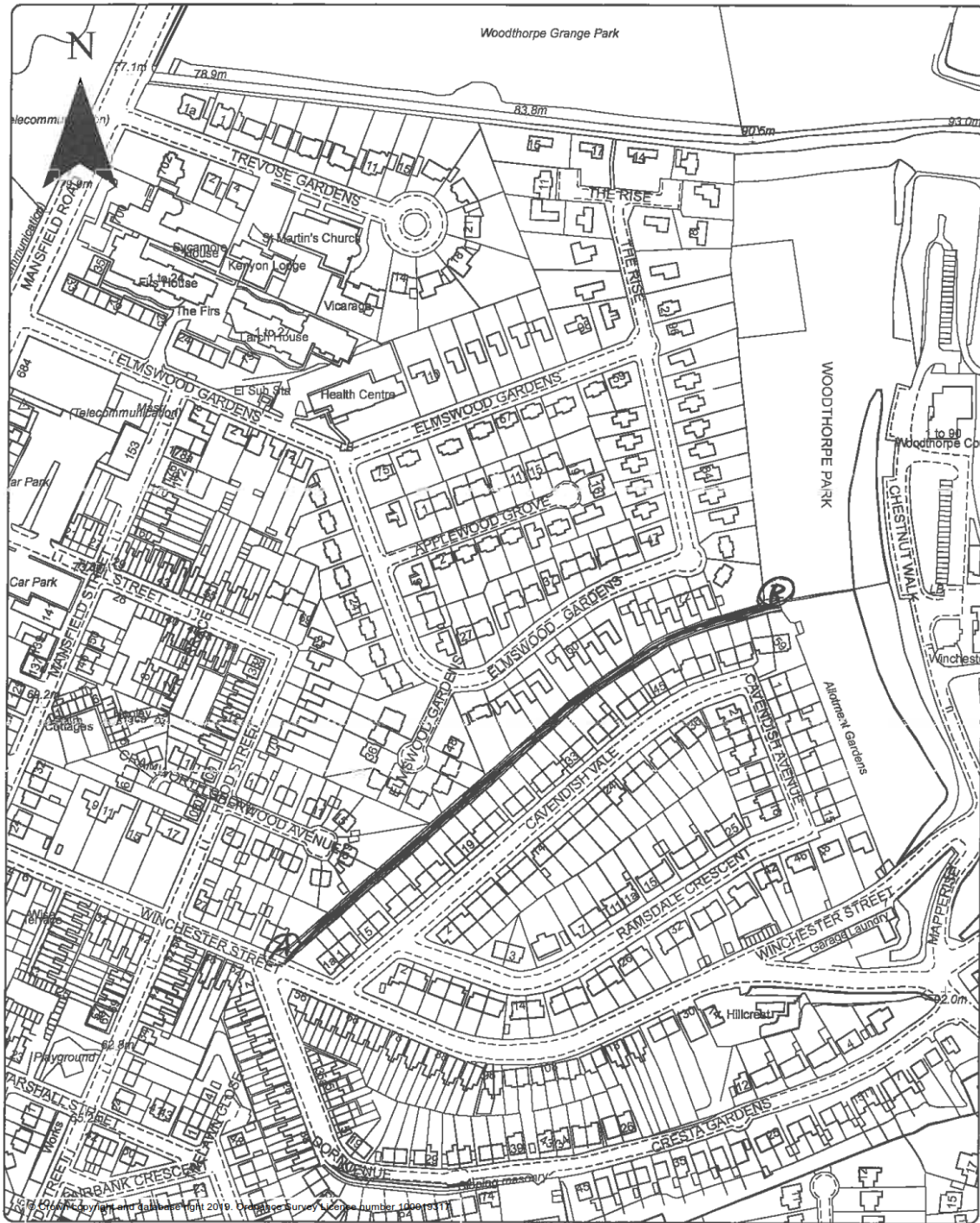

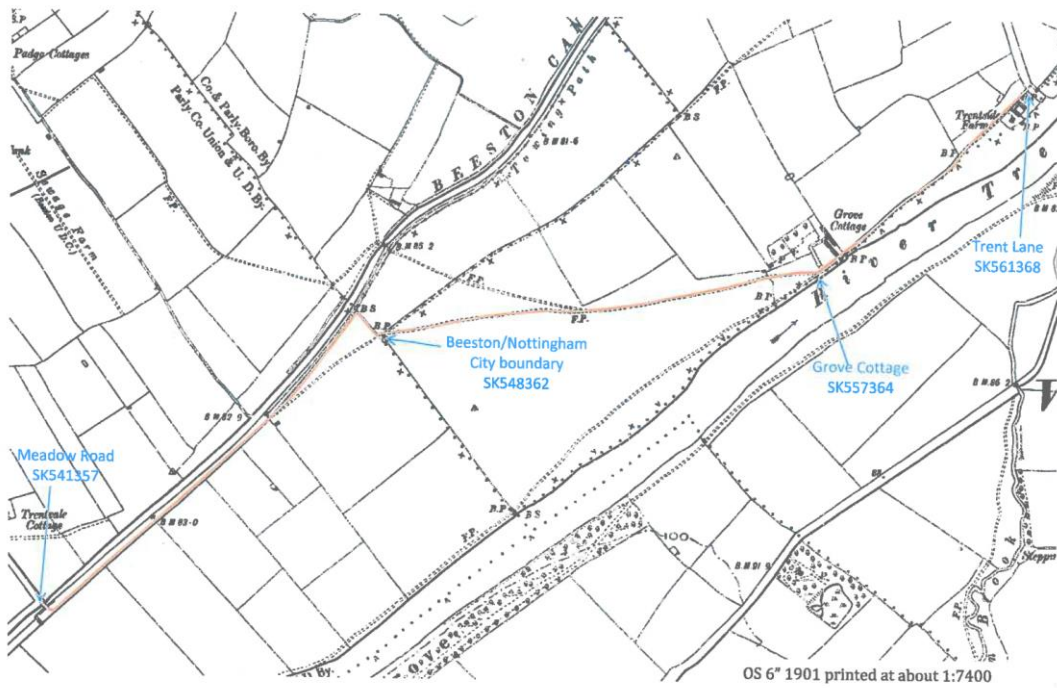

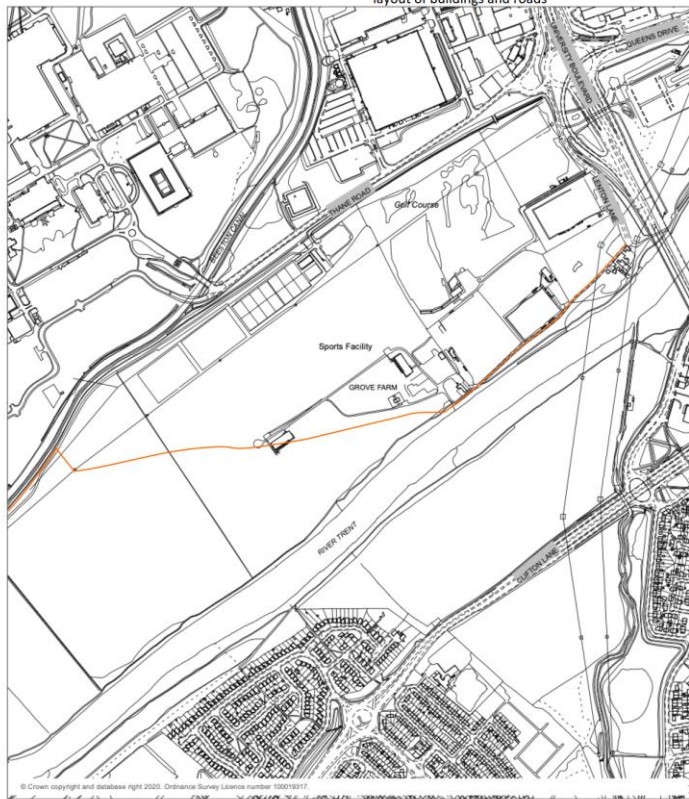

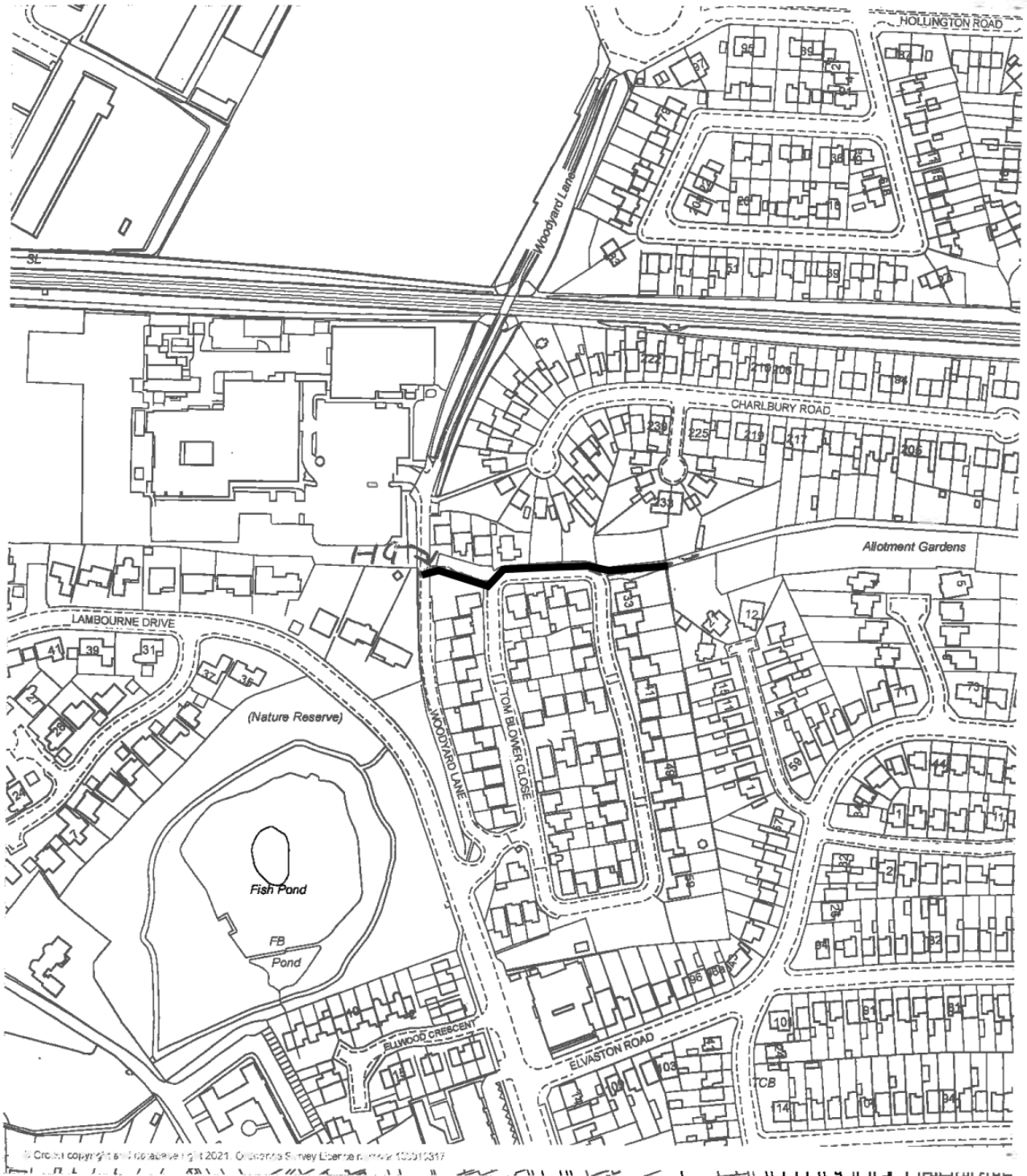
