

<p>IMPORTANT The law requires:</p> <ol style="list-style-type: none"> unless names and addresses, including those of the vehicle owner, together with the registration mark of the vehicle are exchanged at the time of the accident the driver must report it to the Police as soon as possible and in any case within 24 hours; if anyone was injured and the Certificate of Insurance was not produced to the Police at the time of the accident, the driver must report the matter to the Police as soon as possible and in any case within 24 hours and produce the Certificate (or arrange to produce it within five days of the accident). 	<p>You should not</p> <ol style="list-style-type: none"> admit any liability; negotiate or make any agreement with anyone regarding your responsibility for the accident; make or offer any payment whatsoever to any Third Party, if in doubt – consult us; repudiate a claim without our agreement; this may result in Court Action against you by the other party.
