The Development and Change Team are part of Nottingham City Council, who are the data controllers for the personal data (or personal information) that we process about you. When we process personal information relating to you, we will only do so when it is necessary and where we have a lawful reason to do so.

We will use the information provided by you for a number of reasons, depending on the service or reasons for interacting with you. This includes:

- The council being able to appraise the feelings and views of colleague's feelings from colleagues on a mass basis.
- Internal Staff Surveys can help teams improve services to Improve services to internal customers (staff) and external ones (citizens) to help achieve strategic goals of each business area and the council overall.
- To provide aggregated analysis across the council down to team level where available, to deliver insights and identify priorities for council leaders and managers to work on and improve.

When we process your personal information, we will comply with data protection legislation and enable you to exercise your rights contained within the legislation.

What personal information will the Council process?

The information that we collect about you to fulfil the purposes, objectives, or to deliver the services outlined above will relate to your: (this may include all, or some of the following, depending on the service).

- Directorate
- Division
- Team
- Preferences and views of services and support provided by teams at Nottingham City Council
- Your age range
- Sex/Gender Identity

The information we process about you may include the following 'special categories of personal data':

- Physical or mental health – (if you declare a disability)
- Sexual orientation
- Religious or philosophical beliefs
- Race or Ethnic origin

Lawful basis for processing

The basis under which we use your personal information for these purposes is under Article 6(1) a) of the UK GDPR; as it is '*necessary for the performance of a task carried out in the public interest by the Council or in the exercise of official authority vested in the Council*', as it is necessary for us to communicate with staff effectively.

The condition under which we process special categories of personal data is that such use is Article 9(2) g) of the UK GDPR, in that it is 'necessary for reasons of substantial public interest for the equality of opportunity or treatment, so we can see if there are any differences in views for different groups of employees and ensure the consultation fairly represents the different demographics working at Nottingham City Council.

Will my information be shared with other organisations or used for other purposes?

The Council will only share your personal information with other departments within the Council, and with other organisations when it is necessary to provide the services

to you, and when we have a lawful reason to do so. The Council may also share your information when we are obliged to by law.

The information may also be used for the purpose of any other function carried out by the Council. This may include sharing your information across the Council, or with external organisations. The information will only be used for another purpose where it is lawful to do so.

Do I have to provide the information?

You **are not** obliged by statute or contract to provide the information that is specified here. However, if we were not able to process your personal data we may not be able to provide specific support to different groups of people at Nottingham City Council.

How long will the Council retain the data for?

The information that you have provided will be kept for three years to monitor trends within survey results.

The Council publish an Information Asset Register (IAR), this will outline the retention periods for the personal data we process. You can find this IAR on our website <https://geoserver.nottinghamcity.gov.uk/information-asset-register/>

Information Rights

The UK General Data Protection Regulation provides for the following rights as prescribed by the legislation:

A right to request a copy of your information

A right to request rectification of inaccurate personal data

A right to request erasure of your data known as ‘the right to be forgotten’

A right to in certain circumstances to request restriction of processing

A right in certain circumstances to request portability of your data to another provider

A right to object to processing of data in certain circumstances

A right regarding automated decision-making including profiling

However, Nottingham City Council can restrict the above rights in certain circumstances for example to avoid obstructing an investigation, avoid prejudicing the prevention, detection, investigation or prosecution of criminal penalties or to protect the rights and freedoms of others.
