As part of the safe and efficient operation of the road network, Nottingham City Council is deploying 4 traffic count sensors to monitor the number of vehicles, including cyclists, using roads and the number of pedestrians using pavements in the Sherwood area of Nottingham. The roads where sensors are to be located are as follows: Danethorpe Vale, Heatherley Drive, Joyce Avenue and Petworth Drive which form part of a new Low Traffic Neighbourhood area.

We will use the information provided by the sensors to monitor levels of traffic using these roads and help inform future improvements to the infrastructure of the Nottingham highway network. Any improvement works decided upon will be the subject of consultation with local residents before commencement. The basis under which the Council uses personal data for this purpose is that this is necessary for the performance of a task carried out in the public interest by the Council or in the exercise of official authority vested in the Council.

In the first 31 days of the sensors becoming operational, Vivacity Ltd, who process this data on behalf of Nottingham City Council, will undertake video recording on an intermittent basis for the sole purpose of system testing and development. After this time the sensor will be fully operational and produce anonymous data only.
