## Workforce Development Update

The Early Years Team are in the stages of finalising the Continuous Professional Development Plan for Nottingham City's early years workforce for the 2025/2025 academic year, which will be launched for September 2025. We continue with our statutory and core training, have revamped some existing courses and have new courses available that we hope you'll take advantaged of attending. We have maintained our pricing structure for courses for 2025/26 and all courses will be promoted through our 'Stay Connected with Early Years' bulletin, termly newsletter and on the <u>Training Pages</u> of our website.

#### Changes to the administration of our Blended Paediatric First Aid Training

Currently all bookings for the above course are managed by the Early Years Team but many of the questions we receive from delegates are around access to the e-learning modules. From April 2025, the administration of this course will be managed by our colleagues in the Development and Change Team, with the aim of accessing this blended training being a smoother journey for delegates. If you already have a course booked, your place will have been reserved but over the next couple of weeks the website will be updated to include new step-by-step joining instructions for delegates and a frequently asked questions document. Progress on this transition will be shared via our Stay Connected with Early Years Bulletins, but please also keep an eye on the <u>PFA course page</u>



As the early years' entitlements continue to expand, more 2-year-olds are accessing childcare provision and demand for childcare places for 2-year-olds is expected to continue to rise. With this in mind, it has never been more important to ensure that the environment and curriculum for this unique age and stage is planned, understood and delivered appropriately and effectively.

'To Be Two' is a two-part training programme which aims to support and extend the knowledge and understanding of practitioners who are working with 2-year-olds. This training will be delivered through a mixture of theory and practical activities which aim to put a spotlight on provision for all of those involved with this unique age group of children.

The key themes explored through the sessions include:

- Child development
- Key milestones in each prime area
- Early support strategies and interventions
- Characteristics of effective teaching and learning
- Effective environments
- Appropriate curriculums

## SEND Update

#### **Transitions**

As we move into the Summer Term many of you will be supporting children to prepare for transition to school. This can be a worrying and uncertain time for many children, particularly those with Special Educational Needs and Disabilities (SEND).

To enable children to feel secure and settle more easily into their new environment, careful thought and planning will need to take place.

Due to the continued increase in requests being submitted after Panel deadline dates and taking in to account the complications and delays that this causes, going forward any requests received after the above deadline will not be accepted.

#### **Disability Access Fund (DAF)**

From April 1<sup>st</sup> 2025, the DAF funding increased to £938 per eligible child claiming Disability Living Allowance and accessing an Early Years Entitlement place. In line with the lowered age range for children of working parents from 9 months of age being able to access early years entitlements, settings are able to claim for children from this age meeting the above criteria.

If you have claimed DAF for a child in your PVI setting and the child is transitioning to school, please ask the school to claim for the DAF on the School Census in January as the child may potentially still be eligible until they move into a Reception Class.

#### Summer Term 2025 Headcount Information

#### Estimate Funding Payments

Providers will have received part 1 of their Summer Term estimate payments as they are made around 1<sup>st</sup> April 2025, part 2 will be paid around 1<sup>st</sup> May 2025 and part 3 around 1<sup>st</sup> June 2025. Please remember that these are based on the Spring Term headcount.

#### Summer Term Head Count Task

The Summer Term headcount task opened on 31<sup>st</sup> March 2025 and will close on 29<sup>th</sup> April 2025. Please remember that although your portal return will have been submitted by 29<sup>th</sup> April, your estimate payments for the Summer Term will remain the same amount as these are based on Spring Term figures and are signed off in advance of the current term.

#### **Balance Funding Payment**

Providers will receive their Summer Term balance payment around 15<sup>th</sup> July 2025, and, as per the Provider Agreement, any debt owed will be taken off from any amounts owed to you this term (for example, you owe us for a 2 year old, but we owe you for a 3 year old, so if, after this, there is an outstanding debt, we will work with you to agree whether to take this off future payments, or raise an invoice).

#### **Confirmation Reports**

Please look out for an email for the actual deadline for Confirmation Reports, but this is currently provisionally set for 16<sup>th</sup> May 2025. Please ensure you look through your Confirmation Report within the deadline given. It is crucial that the details on your report are accurate, and this is the time to amend, add any new starters or reduce hours for any leavers.

It is particularly important to look at both the universal and extended/expanded columns to ensure that you are claiming the correct hours for all entitlements.

All changes will be included in main balance payments on 15<sup>th</sup> July 2025, unless the Confirmation Report is received after the deadline or further information is required which may take the changes over the deadline for them to be included in the main balance payment.

#### Adjustments

Any amendments due to leavers or starters after the Confirmation Report stage, will need to be made using the <u>Adjustment Form</u>. Please remember that Adjustment Forms need to be completed and submitted by 31<sup>st</sup> August 2025 to receive payment.

#### End of Term Reports

These are now back up and running and will be sent through the portal. We aim to send these out before balance payments reach you. We can't make any changes to the balance payments at this stage and so any changes will need to be made via the <u>Adjustment Form</u>.

#### **Charging Queries**

Following the release of the updated Statutory Guidance governing the early years entitlements, which came into force on 1<sup>st</sup> April 2025, there have been several queries raised with the Department for Education around charging for consumables, and regarding providers setting a certain number of "fully free" places, with the rest being "funded" places, in respect of which providers impose additional mandatory charges. The guidance must reflect the law governing the delivery of the early education and childcare entitlements, which has not changed. The updated guidance puts transparency at the heart of how the entitlement should be passed on to parents. This does not prevent providers from charging for food and other consumables, as long as these charges are not mandatory.

The legislation requires the local authority to secure that places are available free of charge to **each** eligible child in their area, the Department do not consider that offering free places only to some eligible children meets this duty.

Providers can choose to cap the number of early years entitlements places they offer within their setting overall, but all of the places that early years entitlements funding is received for must be accessed free of charge to parents. There must not be any mandatory charges for parents in relation to the free hours.

#### Looking Ahead to Autumn Term 2025

#### Annual Funded Hours

The free childcare working parent regulations set out that a child is currently entitled to 570 hours a year, over no fewer than 38 weeks of the year. From September 2025 this will become 1,140 hours a year, over no fewer than 38 weeks of the year. The year begins when the child first becomes eligible for the entitlement and may be described as the child's "entitlement year". For those children accessing an early years entitlement place before September 2025, their full year of entitlement hours will be adjusted accordingly. For example;

- Children who became eligible in January 2025 will be entitled to 2 terms (Spring and Summer 2025) of 15 free hours a week and one term (Autumn 2025) of 30 hours free hours a week, so 780 funded hours in the year from 1 January 2025 31 December 2025
- Children who became eligible in April 2025 will be entitled to 1 term (Summer 2025) of 15 free hours a week and two terms (Autumn 2025 and Spring 2026) of 30 free hours a week, so 945 funded hours from 1 April 2025 31 March 2026
- Children who become eligible in September 2025 will be entitled to the full 3 terms of 30 hours a week, so 1,140 funded hours from 1 September 2025 31 August 2026

Regarding stretching funded hours, please remember that the 30 hours a week entitlement for children aged 2 and under, does not come into force until 1 September 2025. Therefore, you must ensure that if a child is taking a stretched entitlement, they cannot take up more than 15 hours a week in the Spring and Summer 2025 Terms.

## 2 Years Olds Eligible for Both Working Parent and Families Receiving Additional Support (formerly disadvantaged 2-year-old) Entitlements

A reminder that up until 31<sup>st</sup> August 2025, 2-year-olds who are entitled to both entitlements must be claimed for under the Families Receiving Additional Support Entitlement. From 1st September 2025, these families will be eligible for an additional 15 hours under the Working Parent Entitlement. You may wish to remind these families that they will need to have submitted their application, or reconfirmed their code ahead of the 31<sup>st</sup> August 2025, if they want to access the additional 15 hours.

## **Expansion of the Early Years Entitlements &** Wraparound Childcare Programme

#### **Childcare Expansion Funding**

As part of the government's transformative reforms to childcare, the local authority received capital funding to support the creation of new early years entitlements places for children under the age of 3 in priority wards and capital and revenue funding to support wraparound places for primary school aged children across the City.

To date, we've committed over £30,000 in capital and £330,000 in revenue funding to support the creation of 110 new early years entitlement places and 246 wraparound places that will open over the next year.

## Subject to funding being available, we have 3 application rounds left.

Deadlines for these application rounds are:

- 9<sup>th</sup> May 2025
- 19<sup>th</sup> September 2025
- 23<sup>rd</sup> January 2026

#### **WAC MI Summer Term Data Collection**

Providers receiving revenue funding for new wraparound places will be required to complete a Summer Term Management Information submission. The Summer Term reporting week will be  $9^{\text{th}} - 13^{\text{th}}$  June 2025 and providers will have until Friday 20<sup>th</sup> June 2025 to complete the management information survey.

Maximising existing marketing and promotional materials

Marketing and promotion are important tasks for all providers, especially as the expansion of early education and wraparound childcare continues.

We have seen early demand from existing families, and then a gradual increase of interest from new families. In some areas demand has exceeded expectations, whilst other areas may still be growing.

In a growing and changing childcare market, schools and providers must understand how to market their services to attract and sustain customers.

The Childcare Works HUB has been developed to support group childcare providers, childminders and schools in the expansion of the early years entitlements and implementation of the wraparound programme.




#### iKids Study

Sheffield Hallam University are looking for PVI sector childcare settings to help them explore how mobile devices impact young children's development. #### New Digital Service to Check Early Years Qualifications Now Live!

In January 2025, the DfE announced the **Check an Early Years Qualification (CEYQ) service** to help Early Years (EY) managers verify whether qualifications meet ratio requirements. This free service is now live on the <u>government website</u>

CEYQ service allows managers to check staff qualifications quickly and easily by entering key details such as the qualification name, awarding organisation, and course start date. A clear outcome is provided, which can be printed for records. This tool saves managers valuable time during recruitment and HR processes, ensuring they have appropriately qualified staff in place ahead of the expansion of funded childcare entitlements in September 2025.

CEYQ is currently available for **EY managers only**. Practitioners should continue using the <u>Early Years</u> <u>Qualifications List (EYQL)</u> to check their qualifications and, if further clarification is needed, practitioners can contact the DfE's supplier, Ecctis.

We would encourage you to make full use of this service to streamline qualification checks and support workforce planning.
