Early Years Funding

Summer 2024 Estimate Funding Payments

Providers will already have received part 1 of their estimate payments as they are made around 1st April 2024. Estimate payment part 2 will be paid around 1st May 2024 and part 3 around 1st June 2024.

If you have requested an additional estimate payment for the new 2 year old working parent entitlement, settings should expect to receive this towards the end of April 2024.

If you are new to funding, or have not claimed for a while, but are being paid an estimate payment, your payment may be paid in a lump sum rather than monthly, until you are set up on the system for regular payments. Summer Head Count: 25th March – 26th April 2024

Please remember that although your portal return submission deadline is 26th April 2024, your estimate payments will still remain the same amount as these are based on last terms attendance and are signed off in advance of the current term.

Balance Payments: These will be paid on 15th July 2024 and as per the Provider Agreement, any debt owed will be taken off from any amounts we may owe you this term (i.e. you owe us for a 2 year old, but we owe you for a 3 year old). If after this there is an outstanding debt, we will work with you to agree whether to take this off future payments, or to raise an invoice.

Confirmation Reports: The deadline for Confirmation Reports is 10th May 2024. Please ensure you look through your Confirmation Report within the deadline given. It is crucial that the details on your report are accurate, if they aren't - this is the time to amend, add any new starters or reduce hours for any leavers.

It is particularly important to look at both the universal and extended/expanded columns to ensure that you are claiming the correct hours for all entitlements. So, if you are providing working parent funding this should show in the expanded column. If you are providing 30 hours, 15 should show in both columns. If you are sharing the 30 hour offer with another provider, ensure that your 15 hours are in either the universal or the extended column, depending upon what was agreed when the placement was offered.

All changes will be included in main balance payments on 15th July 2024, unless we receive the reports late or require further information which may take us over the deadline for them to be included.

Adjustments: Any amendments due to leavers or starters after the Confirmation Report stage, will need to be made using the Adjustment Form (available at https://myaccount.nottinghamcity.gov.uk/service/early_years_funding). Please remember adjustment forms need to be completed and sent by 31st August 2024 to ensure payment. Depending upon volumes of adjustments and changes on Confirmation Reports, we aim to include some adjustments on main payments, if not these will be paid at the start of the following term as per the Provider Agreement.

End of Term Reports

These will be available on the portal in July 2024. These reports give a breakdown analysis and most payment queries can be answered using them. Please remember that they will not include supplement payments and the majority of adjustments.

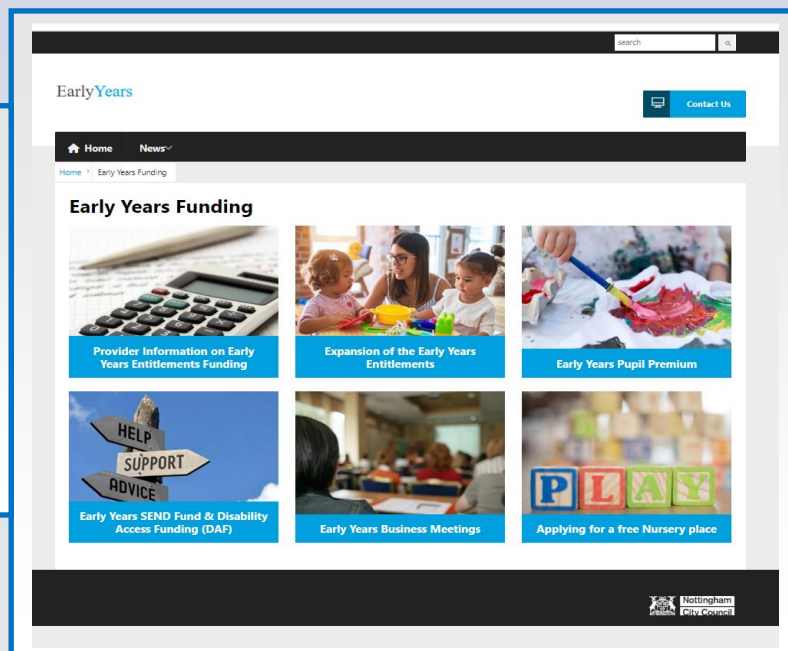

Expansion of the Early Years Entitlements

Working Parent Entitlement for 2 Year Olds Goes Live!

By the time you're reading this newsletter the first of the new early years entitlements will be in place, with working parents of 2 year olds being able to access 15 hours of funded early years provision from 1st April 2024! At the beginning of April, 72% of codes in our LA had been validated, which is above both the regional and national averages so thank you and keep up the prompt validating!

It is expected that many children in this new funded cohort may already have been known to your setting, with children converting from paid for places to partly/wholly funded places as part of this entitlement. As per the current good practice guidance on issuing invoices, all funded provision must be detailed on invoices as being at no cost to the parent, demonstrating it is free at the point of delivery, with any additional costs clearly itemised. Please refer to the latest Provider Agreement and Further Information and Example Documentation pack on the [Early Years Funding](#) pages of the website for more detail on invoice structure.

Specific to note for this particular cohort of funded 2 year olds is the following;

- There may be some circumstances where households may be eligible for both the disadvantaged 2 year old entitlement and the working parents entitlement. Parents can only receive 1 entitlement at a time and the current advice is to access the disadvantaged entitlement to ensure provision is continuous and eligibility isn't lost.
- Don't forget these children can apply for EYPP, DAF & the SEND Inclusion Funding if they are accessing their early years entitlements and meet the additional specific criteria. The new Parent/Provider Agreement template provides consent for checking eligibility.
- As per all working parent entitlements, keep an eye on the Portal and remind parents to reconfirm their eligibility when prompted by HMRC to avoid parents falling into the grace period.

Finally, please remember there is no change to the existing entitlement or the eligibility criteria and application process for the disadvantaged entitlement for 2 year olds.

Looking ahead to September 2024...

With the first milestone passed, we look forward to September 2024 when eligibility extends down to children aged 9 – 23 months, with 15 hours funded childcare becoming available for these children from the term following them turning 9 months old.

From 12th May 2024, eligible working parents of children from 9 months old will be able to register to access this 15 hour entitlement from September 2024. Please encourage parents to check their eligibility on the [Childcare Choices](#) website. Parents can apply for codes for September until 31 August 2024.

Parents who are already claiming Tax Free childcare and need to reconfirm their eligibility between 1st April and 12th May, prior to the new offer opening, will automatically be issued a code in the post by HMRC soon after applications open. If you have any difficulties in checking eligibility codes, please contact earlyyears@nottinghamcity.gov.uk for support.

To mirror the additional estimate payment offered for Working Parents of 2 Year Olds during the Summer Term, we anticipate replicating this for the new cohort of 9-23 month olds that will be eligible for funding during the Autumn Term. This would again be a one-off estimate payment in September 2024, in addition to your normal estimate payment, for this new cohort of children only, paid if the required documentation is submitted. As per the Summer Term additional payment, this will be for 75% of what the funded hours would be for the Autumn Term, with the payment for the actual hours of attendance for these children being reconciled as part of the Provider's normal balance payment in December 2024. Further information will be shared in due course.

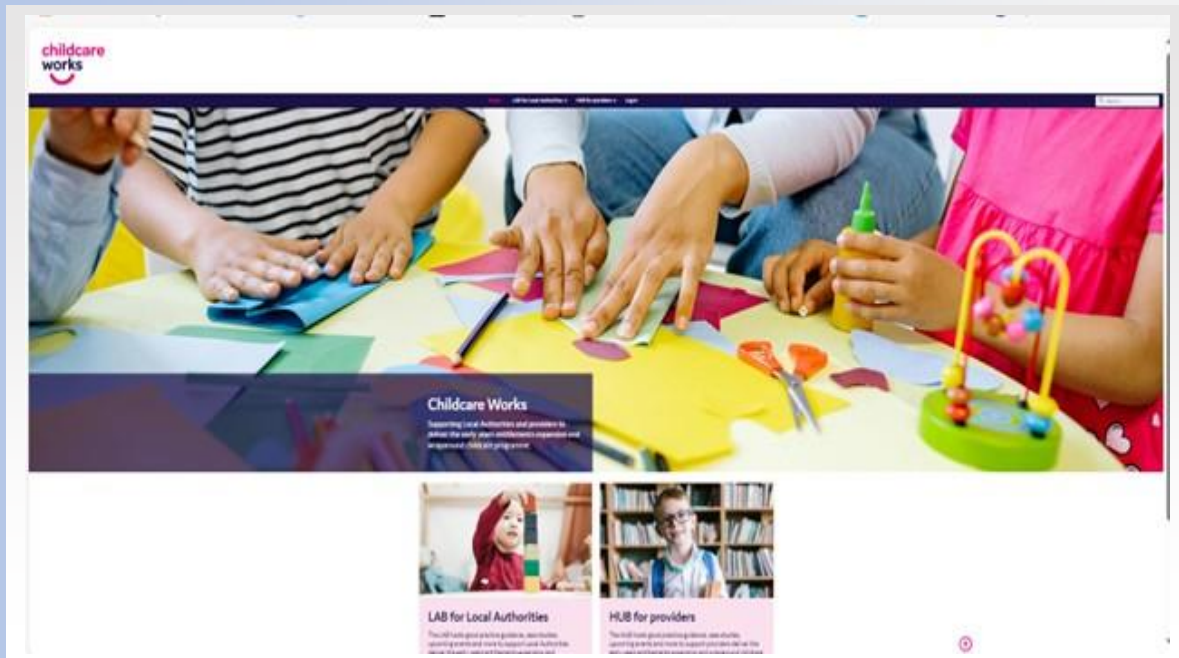
Childcare Works launch new HUB for Providers!

Agreement Trialling Spring Term Evaluation 2024

*These **FREE sessions** provide a valuable discussion and networking opportunity for early years practitioners. Providing updates and ideas to enhance provision and enabling them to develop confidence and consistency when making assessment judgements.*

Sessions are suitable for those working across the sector and we offer sessions for those teaching 3-4 year olds (pre-school) and 4-5 year olds (rising 5s/reception).

*Throughout March we delivered these sessions to **93 practitioners from 61 different settings** (51 schools and 10 PVI's) having representation from 12 different school trusts, nursery chains, maintained schools and independent nurseries.*

To Be Two

30th April 2024 & 16th May 2024 @ Castle Cavendish, 9:30am – 12:30pm, £50pp

As the early years' entitlements expand, more 2 year olds will be accessing childcare provision and therefore childcare places for 2 year olds will be expanding. It has never been more important to ensure that the environment and curriculum for this unique age and stage is planned, understood and delivered appropriately and effectively.

'To Be Two' is a two-part training programme which aims to support and extend the knowledge and understanding of practitioners who are working with two-year-olds. This training will be delivered through a mixture of theory and practical activities which aim to put a spotlight on provision for all of those involved with this unique age group of children.

The key themes explored through the sessions include:

- Child development
- Key milestones in each prime area
- Early support strategies and interventions
- Characteristics of effective teaching & learning
- Effective environments
- Appropriate curriculums

Making Interactions

Count 0-2 Years

1st May 2024

9:30am – 12:30pm

£45pp

Combining theoretical concepts with practical activities, this session gives practitioners the opportunity to reflect on their interactions with our youngest children and explore what makes an effective interaction, with babies and toddlers. Participants will leave the session equipped with ideas on practical resources and activities to help support quality interactions through their day-to-day interactions with children, including making use of regular routines such as snack or nappy time!

Making Interactions Count 3-5 Years:

20th May 2024, 9:30am – 12:30pm @ Castle Cavendish, £45pp

This session, for practitioners working with 3-5 years olds will furnish participants with practical ideas, which will help them to explore different techniques to maintain the learning momentum when interacting with children, supporting them to engage in sustained shared thinking. It will also help participants to develop their confidence to assess the quality of interactions taking place in the practitioner's environment, indoors and outdoors.

Developing Early Number

Sense 3-4 Years

The session will enable you to develop your understanding of early number sense and help you to reflect on how your learning environment engages children and practitioners in mathematical conversations. The course will help develop practitioners' understanding of Early Number Sense and understand how to develop a mathematically engaging environment.

Forest School Camp Fire Workshop

A new outdoor workshop held at Bulwell Forest Community Gardens and run by a fully qualified Forest School Practitioner. The Forest School Leader will take you through a range of activities including building campfires, fire lighting and what fuel to use, along with camp-fire safety. The workshop aims to provide you with confidence and tips for having camp-fires in your own outdoor areas and will also look at a variety of activities and treats for EYFS children to enjoy around the fire.

Disability Access Fund Increase

The Disability Access Fund is £910 per year for eligible children from 1st April 2024, including 2 year olds!

The criteria:

- The child is in receipt of Disability Living Allowance (DLA)
- The child is in receipt of either of the 2 year old early years entitlements; for disadvantaged children or the entitlement for working parents
- The child is in receipt of the 3 and 4 year old early years entitlement
- The child is not attending a reception class in a primary or infant school/academy

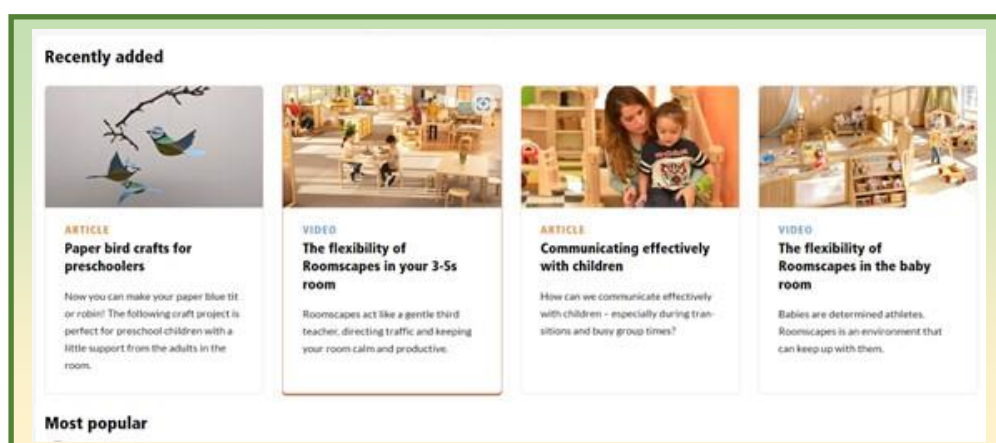
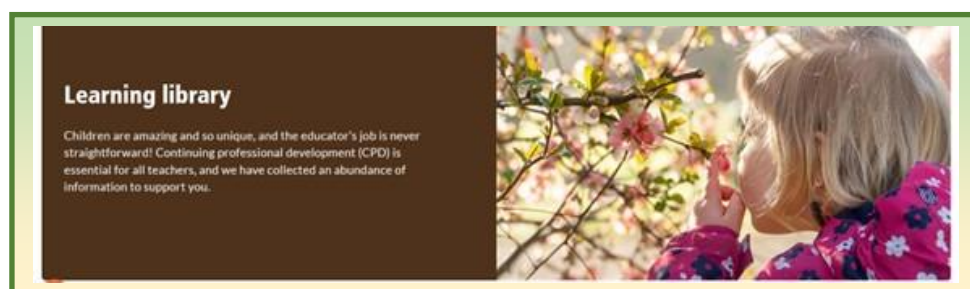
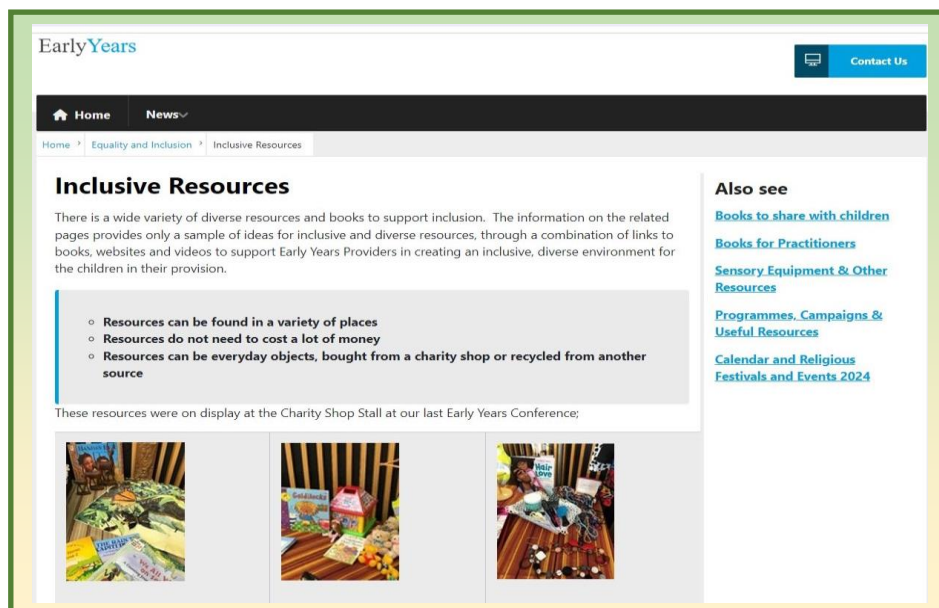
From 1st September 2024, children from 9 months of age accessing the working parent early years entitlements and meeting the above criteria will also be eligible.

Childminder Consultation Roadshow

The Department for Education is running an online Childminder Consultation Roadshow **on Thursday 18th April 2024. The event will start at 7pm (please aim to join 15 minutes before the start time) and finish at 8pm** and will be held **online via Teams in a webinar format.**

The Department's childminder consultation marks an important part of the government's plan to recruit and retain more childminders, recognising the important role they play in the childcare sector by providing high quality, flexible, entitlements and wraparound childcare. The Department knows childminders face specific challenges and the consultation seeks to understand and address these issues.

This event is an opportunity for childminders to hear about the Department's ambitions for childminders, including proposals in the Department's childminder consultation. It is also an opportunity for the DfE to hear from childminders to help shape and manage our next steps.

The event agenda will include speakers from the DfE and a Q&A session with DfE officials working on childminder policy and the early years entitlements and wraparound programmes.

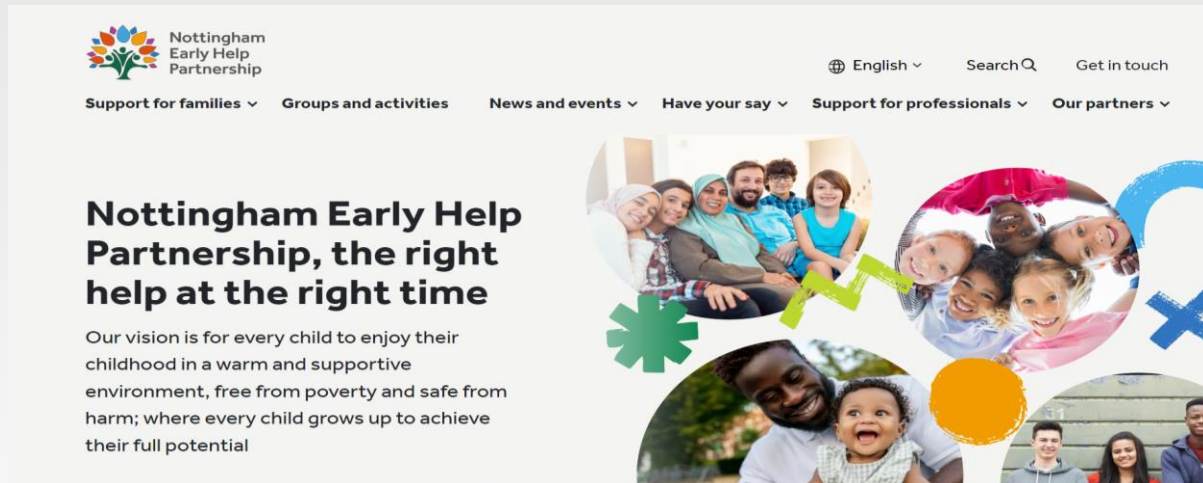

Nottingham Early Help Partnership

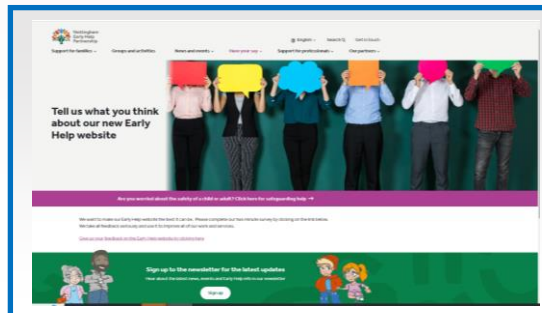
