Describe the steps you intend to take to promote the four licensing objectives:

a) General – all four licensing objectives (b, c, d and e) (please read guidance note 10)

We will ensure will put in all measures to ensure the premises operates responsibly and in full compliance with the law while maintaining a safe and enjoyable environment for customers, staff, and the surrounding community.

The main delivery of this will be through staff training and the presence of managers and responsible people to keep standards and due diligence at all times. Our intention is to provide a safe and quality food and drink offer to compliment our services as a Padel Tennis centre. We anticipate building and maintaining a positive relationship with the local community.

b) The prevention of crime and disorder

- **CCTV and Security:** Install and maintain high-quality CCTV systems covering all key areas of the premises. Retain footage for at least 28 days and make it available to police upon request. Employ trained security staff (SIA-licensed) during high-risk periods.
- **Staff Training:** Ensure all staff are trained to identify and deal with disorderly conduct and illegal activity, including drug misuse and underage sales.
- **Incident Log:** Keep a detailed incident logbook to record any criminal or anti-social behaviour. Review incidents regularly to improve practices.
- **Alcohol Management:** Implement a strict Challenge 25 policy and use a refusals book to deter underage and proxy alcohol sales.

c) Public safety

- **Risk Assessments:** Carry out regular fire safety and health & safety risk assessments. Ensure all fire exits are clearly marked, unobstructed, and functional.
- **Capacity Management:** Monitor and control the number of patrons in the venue at any time to avoid overcrowding.
- **First Aid and Staff Preparedness:** Ensure that first-aid kits are available and that trained first-aiders are always on-site. Train staff in basic emergency response procedures.
- **Maintenance:** Conduct regular checks and maintenance on electrical, gas, and structural installations to ensure the building is safe.

d) The prevention of public nuisance



- **Noise Control:** Install soundproofing where necessary and use limiters on music systems. Monitor noise levels during operating hours, especially in the evening.
- **Patron Management:** Display clear signage requesting customers to leave quietly and avoid loitering. Assign staff or security to manage crowds at closing time.
- **Waste and Litter:** Provide adequate bins and arrange for regular waste collection. Staff will clear up litter around the premises regularly.
- **Lighting:** Ensure external lighting does not disturb local residents while maintaining adequate visibility for safety.

e) The protection of children from harm

- **Age Verification:** Enforce a Challenge 25 policy with valid ID checks (passport, photo driving licence, PASS cards). Maintain a refusals log.
- **Restricted Access:** Do not allow unaccompanied minors on the premises in the evening, and never during alcohol-led events.
- **Entertainment:** Vet any entertainment involving children to ensure appropriateness and safeguard measures. Avoid showing inappropriate films or performances.
- **Staff Training:** Provide child protection training to staff so they understand how to recognise and report potential harm or safeguarding concerns.
