You said (provider)	Our response (NCC)
Drug and alcohol addiction - Mental Health	Drug and alcohol dependency services are public health commissioning functions, we will update the MPS to include public health commissioning intentions which include substance misuse prevention and treatment.
Day services	Nottingham City Council are currently reviewing internal day- service provision and these comments will be passed to commissioners involved in that work.
Early Intervention and prevention – Mental Health	The introduction in the MPS has been amended to clarify that the MPS relates to Adult Social Care (ASC) services and that we will continue to work within the ICS to complement their commissioning of primary and secondary mental health services and NHSE (specialist inpatient mental health services and services in secure settings such as prisons). Also there is the potential for early intervention and prevention to be a future topic at a provider forum.
Workforce challenges and capacity	Currently in development is an external ASC workforce strategy for Nottingham and Nottinghamshire following a recent workforce project with Skills for Care which identified key priorities for the care workforce in Nottingham. Details around this have been added into the MPS.
Residential Care	The residential care 65 plus messages to the market section of the MPS has been updated to acknowledge residential care may be the right place for some citizens.
Quality of providers	Any concerns need to be fed to Nottingham City Council contracts team and the safeguarding team. We respond to whistle blowing and quality audit processes and check in with the CQC.
