

Energy efficiency grants - guidance for landlords

updated: 30 11 2023

Improve the energy efficiency of your properties and help your tenants reduce their energy bills.

Under Central Government legislation, domestic private rented properties are required to meet a minimum energy efficiency standard (MEES) before they can be rented to tenants. The current MEES requirement is an energy performance certificate (EPC) rating of E or above, unless an exemption applies and is registered.

Various schemes are available which aim to reduce fuel poverty and improve the energy efficiency of homes across the UK which will help landlords meet their MEES requirements. Many of these are free or at a reduced cost for properties in the Private Rented Sector (PRS); eligibility criteria usually incudes factors such as household income of tenants, council tax band of the property, the EPC rating of the property, suitability of property for proposed measures and funds are often distributed on a first come first served basis.

Connected for Warmth

Fully funded loft and cavity wall insulation Eligibility criteria for **free** measures

 - o houses in Council Tax Bands A-D
 - households are **not means tested**
 - o Suitability of property for the measures
 - EPC rating of C or below



Air Source Heat Pumps

Eligibility criteria for reduced cost Air Source Heat Pumps

 - available to households that don't currently have a central heating system in any Council Tax Band, see appendix one
 - EPC rating of E,F, or G
 - o in receipt of means rested benefits, see appendix two
 - Landlords may need to make a financial contribution

Great British Insulation Scheme

Landlords are included for **free or cheaper insulation**, such as under floor insulation, room in roof insulation, loft insulation, cavity wall and internal wall insulation, subject to property suitability and ECO installer assessment.

Eligibility criteria for free measures

- PRS properties EPC rated D G
- in Council Tax bands A-D
- the tenant being eligible, qualifying benefits see appendix two

The Great British Insulation Scheme is a Central Government energy efficiency scheme to tackle fuel poverty and help reduce carbon emission. The scheme is regulated by OFGEM, but funded by energy supply companies.

The Boiler Upgrade Scheme grants fitting Air Source or Ground Source Heat Pumps.

Eligibility criteria for a grant towards the cost

- Full details here www.gov.uk/apply-boiler-upgrade-scheme/check-if-youre-eligible
 - Replacing a fossil fuel heating systems (such as oil, gas or electric) with a heat pump
 - Property must have a valid Energy Performance Certificate with no outstanding recommendations for loft or cavity wall insulation.

The Energy Company Obligation 4 (ECO 4)

Energy suppliers are required to help households reduce the costs of their home heating by fitting energy-saving measures. You may get help with the cost of insulation work, replacing or repairing a boiler, or other upgrades to your heating.

Different energy suppliers have different amounts of support and offer different types of improvements. Appendix 3 includes some locally active installers, but others will be operating in your area.

Eligibility criteria for free measures -

- PRS properties EPC rated E, F or G
- the tenant being eligible, qualifying benefits, see appendix 2

Smart Meters

Smart meters measure how much energy a household is using in near-real time, and show what it's costing on a handy in-home display. Smart meters help households take control of their energy use and find ways to save money.

Either the landlord or the tenant can request a **free smart meter** from the electricity supplier to the property.

Warm and Wise

The Age UK Warm & Wise service is totally free and available to anyone 50 years of age or above in all tenures. Home Energy Advisors can offer information, signposting and advice via telephone, email, or home visits.

They can also install small measures such as draught excluders, light bulbs and timers, provide support with installing TRV's, minor repairs and refer households for support with boilers, central heating and insulation.

Appendix 1 - Connected for Warmth Air source heat pumps

Details of eligibility criteria for privately rented properties that are off-gas and heated by one of the following are likely to be eligible

- electric storage heaters
- room heaters
- open fires
- electric warm air systems
- electric underfloor or ceiling heating (not connected to an electric boiler)
- oil boiler
- LPG boiler
- electric boiler
- solid fuel boiler

Appendix 2 – Income and benefit eligibility criteria

Households in receipt of the following benefits

- Income based Jobseekers Allowance
- Income related Employment and Support Allowance
- Income Support
- Pension Credit Guarantee Credit
- Working Tax Credit
- Child Tax Credit
- Universal Credit
- Housing Benefit
- Pension Credit Savings Credit
- Child Benefit (household income cap applies)

Appendix 3 – Local Installers for ECO Measures

Energy Company Obligation 4 is a Central Government scheme regulated by OFGEM, but funded by energy supply companies.

Access to the funding is via ECO installers who are private companies. The different companies will carry out different measures. ECO installers are encouraged by OFGEM to do two or more measures, rather than just one.

It is not a Nottingham City Council scheme, but we know of many ECO installers operating locally and what measures they are doing – see list below, others are expected to also operate in Nottingham.
