The **WPL Team** are part of Nottingham City Council, who are the data controllers for the personal data (or personal information) that we process about you. When we process personal information relating to you, we will only do so when it is necessary and where we have a lawful reason to do so.

We will use the information provided by you for a number of reasons, depending on the service or reasons for interacting with you. This includes:

Management of the Workplace Parking Levy scheme.

When we process your personal information, we will comply with data protection legislation and enable you to exercise your rights contained within the legislation.

## What personal information will the Council process?

The information that we collect about you to fulfil the purposes, objectives, or to deliver the services outlined above relates to your:

- Name
- Contact details (Business phone numbers, email address and postal addresses)
- Business payment details (Invoicing/Direct Debit)
- Employee number plates during compliance surveys

# Lawful basis for processing

The basis under which we use your personal information for these purposes is that this is necessary for the performance of a task carried out in the public interest by the Council or in the exercise of official authority vested in the Council. This is a result of the powers or duties contained in the **Transport Act 2000**.

Will my information be shared with other organisations or used for other purposes?

### **OFFICIAL**



The Council will only share your personal information with other departments within the Council, and with other organisations when it is necessary to provide the services to you, and when we have a lawful reason to do so. The Council may also share your information when we are obliged to by law.

In relation to this service, the Council will share your personal information with:

- Traffic management
- Planning and Transport Strategy

The information provided by you may also be used for the purpose of any other function carried out by the Council. This may include sharing your information across the Council, or with external organisations. The information will only be used for another purpose where it is lawful to do so.

#### Do I have to provide the information?

You are obliged by statute to provide some of the information that is specified here.

## How long will the Council retain the data for?

The information that you have provided will be kept for as long as a WPL licence is held. Information will be retained for three years after cancellation of a WPL licence (the end of its life cycle).

Automatic Number Plate Recognition (ANPR) images generated by the WPL mobile ANPR unit to enforce compliance with the WPL are retained for three months from the date employer notified of outcome. In the event of a non-compliant survey, all still images should be retained for a period of two years to allow the opportunity for two compliant surveys to be undertaken as per WPL policy.

Site survey analytical reports produced by the WPL team in compliant cases will be retained for two years from the date the record was created. In the event of a non-compliant outcome, reports will be retained for a period of five years.

The Council publish an Information Asset Register (IAR), this will outline the retention periods for the personal data we process. #### **Information Rights**

The UK General Data Protection Regulation provides for the following rights as prescribed by the legislation:

- A right to request a copy of your information
- A right to request rectification of inaccurate personal data

- A right to request erasure of your data known as 'the right to be forgotten'
- A right to in certain circumstances to request restriction of processing
- A right in certain circumstances to request portability of your data to another provider
- A right to object to processing of data in certain circumstances
- A right regarding automated decision-making including profiling

However, Nottingham City Council can restrict the above rights in certain circumstances for example to avoid obstructing an investigation, avoid prejudicing the prevention, detection, investigation or prosecution of criminal penalties or to protect the rights and freedoms of others.
