Community Involvement

As Mapperley Councillors we have conducted monthly ward walks with Neighbourhood Development Officers, local Housing Patch Managers, Police and Community Support Officers and Neighbourhood Operations Managers.

We held weekly surgeries at St Ann's Valley Centre on Wednesdays 6pm-7pm and Saturdays am appointment only which gave constituents the opportunity to voice their concerns or suggestions.

Monthly Neighbourhood Action Team meetings held with Police, Housing Patch Managers, Neighbourhood management, CCTV operators, Prostitution Task Force, Cleansing Services management and visiting officers from health services to support a joined up approach to neighbourhood priorities.

We have held regular meetings to steer the initial feasibility for rebuilding the Wells Community Centre and sourcing funding. Regular meetings have taken place to consult with the community on the design and possible use of the new centre.

Regular meetings with Mapperley Park Residents Association have consulted on improving the roundabout on Lucknow Drive (including a community planting session), tree stump removal and replanting and consultation on parking issues.

Responding to residents' concerns, we carried out parking surveys in Woodborough Road area and safer access for pupils around Nottingham Academy on Ransom Drive.

Councillors have attended local meetings of St Ann's Tenants and Residents, ACNA (Afro-Caribbean National Artistic Centre), Refugee Forum, Coppice Park Friends, Mapperley Park Residents Association, Neighbourhood Watch, St Ann's Allotments, Hogarth Academy Governors.

Regular news letters and leaflets have kept residents informed including articles in Mapperley Park Residents' Magazines and letters to local residents including information about local events and planning applications.

Ward Work and Achievements

We consulted on and introduced a resident's parking scheme to resolve traffic flow issues and increasing commuter parking in the Mapperley Road area.

A mobile 3G camera has been regularly located in different sites to monitor antisocial behaviour and fly tipping in areas with the greatest reported incidents.

An extra October garden waste collection (of leaves only) was organised again this year for areas prone to flooding and resulted in over 12 tons of leaves collected.

Free 4 All Good Neighbours Project was funded to support Wells Road residents. Numbers attending continue to increase.

A dangerous junction of Redcliffe Road emerging on to Magdala Road has had agreed funding to increase pedestrian safety with increased paving area and improve driver visibility of oncoming traffic. This will be carried out subject to public consultation.

Challenges

The main challenges for Mapperley are maintaining local neighbourhood policing priorities with reduced budgets. CPOs still patrol but numbers have reduced.

Increase in burglary being met with community safety materials such as advice leaflets, shed alarms and window alarms.

Knife crime being deterred by stop and search directed at specific areas directed by intelligence.

Fly tipping has increased in areas not previously affected.
