SEND Funding Key Dates for Summer 2 Panel

Moderation week will take place between Monday 12th May 2025 - Friday 16th May 2025 at 12 noon. Contribute to Research on SEND

Nutrition EYFS Update

From September 2025, the Department for Education are introducing new nutrition guidance in the EYFS statutory framework, which will replace the 'Examples menus for early years settings in England' guidance. The new guidance has been developed with nutrition and sector experts. It will help early years providers understand how to meet the existing EYFS requirement: 'Where children are provided with meals, snacks and drinks, these must be healthy, balanced and nutritious'. From September 2025, providers will be required to have regard to the new nutrition guidance, meaning they must take it into account and should follow it unless there is good reason not to.
