The premises will be operated responsibly and in accordance with the premises licence and all relevant licensing requirements. Staff will be appropriately trained and instructed to promote the four licensing objectives. The premises will maintain a safe and orderly environment, prevent crime and disorder, minimise public nuisance and take appropriate steps to protect children from harm.

b) The prevention of crime and disorder

The premises will operate a Challenge 25 policy. Staff will be trained to request valid photographic identification from anyone who appears to be under 25 when purchasing alcohol. Staff will not sell alcohol to anyone who is intoxicated or where there is reason to believe the sale may contribute to crime or disorder.

The premises will maintain appropriate security measures, including CCTV where available, and staff will monitor the premises and surrounding area for any incidents of crime or disorder. Any incidents will be recorded and reported to the relevant authorities where appropriate.

c) Public safety

The premises will be kept clean, safe and free from unnecessary obstructions. Staff will be aware of fire safety procedures and emergency arrangements. Any hazards identified within the premises will be dealt with promptly. The premises will not permit overcrowding and staff will monitor the premises to ensure the safety of customers and staff.

d) The prevention of public nuisance

The premises will be operated in a manner that minimises disturbance to nearby residents and businesses. Staff will monitor noise and customer behaviour outside the premises and will take reasonable steps to prevent excessive noise, nuisance or obstruction.

Customers will be encouraged to leave the premises quietly and responsibly, particularly during later hours. Any litter or waste associated with the premises will be dealt with promptly.

e) The protection of children from harm

The premises will operate a Challenge 25 policy for the sale of alcohol. Any person who appears to be under 25 will be required to provide acceptable photographic identification before alcohol is sold.

Staff will receive appropriate training in age-restricted sales and will refuse sales where suitable identification is not provided. The premises will not sell alcohol to children and will take reasonable steps to prevent proxy sales where staff have reason to believe that alcohol is being purchased on behalf of a child.

NOTES ON REGULATED ENTERTAINMENT

In terms of specific **regulated entertainments** please note that:

- Plays: no licence is required for performances between 08:00 and 23.00 on any day, provided that the audience does not exceed 500.
- Films: no licence is required for 'not-for-profit' film exhibition held in community premises between 08.00 and 23.00 on any day provided that the audience does not exceed 500 and the organiser (a) gets consent to the screening from a person who is responsible for the premises; and (b) ensures that each such screening abides by age classification ratings.
- Indoor sporting events: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000.
- Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
- Live music: no licence permission is required for:
 - o a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
- Recorded Music: no licence permission is required for:
 - o any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - o any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - o any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.

- Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
- Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - o any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - o any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - o any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - o any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
