

# National Wraparound Childcare Programme: Information for maintained schools and academy trusts

The National Wraparound Childcare Programme supports the government's ambition for all parents and carers of primary school-aged children who need term time, childcare during the hours of 8am to 6pm, to be able to access it in their local area by September 2026. Schools are central to the delivery of the programme as they operate at the heart of the community, understand the needs of local families, and are usually the first port of call for parents for wraparound childcare. The expectation is that most parents can access childcare through provision on a school site (either provided directly by the school or by an external provider). Where there is a strong rationale for this not to be the case, the minimum expectation is for schools to work collaboratively with their local authority to ensure parents are, at a minimum, signposted to appropriate provision.

Each local authority has received funding to support the costs associated with place creation and expansion, for example, staffing, equipment and resources. This removes the financial risk for schools when starting or expanding their provision. Improved access to employment and education opportunities benefits parents, and schools' and children benefit from a softer start to the school day.

# Determining The Role of Your School in the National Wraparound Childcare Programme

# **Session 1a: Programme Overview**

This short recording introduces the National Wraparound Childcare Programme including:

#### **Session 1b: The Roles and Schools and Trusts**

The role of Schools and Trusts in the delivery of wraparound childcare is the focus of this session.

#### **Session 2: Delivery Models**

Schools can deliver provision themselves, work with external providers and childminders, or develop cluster or hub models.

- Discusses the interaction between wraparound and existing provision and ideas shared regarding how they work together

#### **Session 3: Is There Demand?**

This session will provide you with hints and tips to assess potential demand within your school.

#### **Session 4: Overcoming Common Challenges**

Recruitment, lack of space, transport, insufficient time, parental affordability and inadequate demand are commonly cited as challenges. This session will discuss each of these challenges in turn and provide insight into how they can be overcome.

By this session you should have a strong understanding of the programme, how it can be delivered and how to assess demand in your school. You will understand the limitations of relying on reasonable justification and will have ideas about how to address common challenges. 
The Childcare Works HUB hosts two online toolkits to support maintained schools and academy trusts with the development of early years services and wraparound childcare.
