Letter from the Prime Minister to Parents

To mark last week's childcare expansion milestone, Prime Minister Keir Starmer has written to parents reaffirming his Plan for Change promise to give children the best possible start with 75% of 5-year-olds reaching a good level of development by 2028. New Ofsted Education Inspection Framework (EIF) launches 10th November 2025



The new EIF will come into force later this term and will set out how Ofsted inspects registered early years settings, including principles that apply to inspection and the main evaluations that inspectors make. School Based Nurseries Capital Programme - Phase 2

At the beginning of September, the Department for Education launched Phase 2 of the School Based Nurseries Programme, which will be a school bidding round, focused on delivering places in the 2026-27 academic year. This phase will prioritise quality bids from schools serving some of the most disadvantaged communities, delivering thousands of new places nationally for families who need them most. The programme can provide up to £150,000 in capital funding for eligible state-funded primary schools and maintained nursery schools to help create new, or expand, existing nursery provision. Applications will be open from 22nd September – 11th December 2025 and further information and application guidance can be found here.

Free Oral Health Training and Supervised Brushing Programme

The EYFS Statutory Framework expects early years providers to promote children's good health and oral hygiene, which should be introduced to children at an early age. Nottingham Oral Health Improvement Team are offering free oral health training to provide accurate, evidence-based oral health promotion advice to both children and their parents. The Team also offers supervised brushing programmes for early years settings. Eligible participating setting will receive a full range of free resources for their setting and for the children to take home. Winter Health Letters for Parents
