## 1. Introduction / Background

#### 1.1 National/local context and evidence base

Despite the widespread use of contraception, unplanned pregnancy remains an issue, ONS data published in 2019 shows that although the rate remained the same for women under 16, the actual number of conceptions in that age group increased for the first time in 11 years. <sup>1</sup> 25.2% of all conceptions in England led to a termination of pregnancy this was the second consecutive year that an increase had been seen.

Locally, in Nottingham the conception rate in under 18s in 2019 was 24.1 per 1000, this was higher than the national rate of 15.7 and higher than the comparator average of 20.8 with Nottingham being higher than most similar cities. 48.7% of all conceptions in under 18s led to an abortion in 2019, this was a significant increase from 27.8% in 2017.

Emergency contraception has the potential to reduce unintended pregnancy rates, thereby reducing the number of terminations. Equitable provision of and easier access to Emergency Hormonal Contraception via pharmacies that has the potential to improve the effectiveness of this contraceptive method by reducing the time interval between unprotected intercourse and initiation of treatment.

Levonelle 1500 a progestogen post-coital contraceptive (PCC) or Emergency Hormonal Contraceptive (EHC) containing Levonorgestrel or Ulipristal Acetate 30mg Tablet(s) in accordance with guidance set out in the associated Patient Group Direction (PGD) documents) will be provided on a Patient Group Direction (PGD) by trained community pharmacists in nominated Nottingham City pharmacies. Timely access to EHC is key to its potential success.

The need for provision of this service fits within national and local targets to reduce unplanned teenage pregnancy. Nottingham City's 'The Nottingham Strategic Council Plan 2021-23' states as one of its targets is to reduce teenage pregnancy. Wards with high rates of teenage conception and termination of pregnancy within Nottingham City have been identified.

Pharmacy - A Way Forward for Public Health, published in 2017<sup>2</sup> sets out opportunities for commissioner and provider led action at a local level to realise community pharmacy's key role in enabling a healthier nation. It encourages commissioning of sexual health services through pharmacy, including access to EHC, condoms and signposting to appropriate sources of advice and support, particularly in disadvantaged areas.

This Locally Commissioned Public Health Service (LCPHS) aims to provide part of a comprehensive sexual health service via an accessible local pharmacy, which will contribute to the improvement of health, sexual health and wellbeing and reduce inequalities in sexual health.

The key aims of the EHC service Locally Commissioned Public Health Service (LCPHS) are:

- To increase the knowledge, especially among young people, of the availability of emergency contraception and contraception from pharmacies.
- To improve access to emergency contraception and sexual health advice.
- To help contribute to a reduction in the number of unplanned pregnancies and termination of pregnancy rates especially amongst the teenage population.
- To increase the appropriate use of EHC by women aged 13 years to 24 years old that have had unprotected sex / contraception failed and help contribute to a reduction in the number of unplanned pregnancies in the client group.
- To refer clients, especially those from hard to reach groups, into mainstream contraceptive services.
- To increase the knowledge of risks such as STIs associated with unprotected sexual intercourse.
- To refer clients who may have been at risk of STIs to an appropriate service.
- To strengthen the local network of contraceptive and sexual health services to help ensure easy and quick access to advice.

The Provider (i.e. the pharmacy contractor) will be reimbursed the cost of the hormonal post coital contraception issued plus VAT on cost and a professional fee.

## 3. Service Description

- The Provider (i.e. the pharmacy contractor) will supply Levonorgestrel Emergency Hormonal Contraception (EHC) <u>or</u> Ulipristal Acetate 30mg Tablet(s) when appropriate to clients in line with the requirements of the Nottingham City Council Patient Group Direction (PGD). Clients from 13 years to 24 years of age are eligible to receive treatment.
- The Provider will offer a user-friendly, non-judgmental, client-centred, confidential service.
- The supply will be made free of charge to clients aged 13 years to 24 years.
- The Provider will ensure this pharmacy service is provided in compliance with Fraser guidance<sup>3</sup>. Pharmacists participating in the scheme MUST adhere to this child protection guidance.
- If the individual is less than 13 years of age the pharmacist should call the on-call doctor from the East Midlands Children and Young People Sexual Assault Service (EMCYPSAS) for support and to decide who will administer EHC. In addition, a Safeguarding referral to Children's Social Care should always be made. This is because the Sexual Offences Act states that individuals under 13 years of age cannot consent to have sexual intercourse, therefore this is statutory rape. See the safeguarding section of this document for details on making EMCYPSAS and Children's Social Care referrals.
- Further information can be found in the safeguarding section in this document.
- The Provider will link into existing networks for community contraceptive services (e.g. Nottingham University Hospital's Integrated Sexual Health Services or advice women to consult with their General Practitioner.
- The Provider will ensure clients excluded from the PGD criteria are signposted to another local service
  that will be able to assist them, as soon as possible, e.g. EMCYPSAS, social care, GP, Integrated
  Sexual Health Clinics, or the Walk-In Centre.

<sup>3</sup>Fraser Guidelines – based on a House of Lords Ruling; A health professional can give advice or treatment to a person under 16 without parental consent providing they are satisfied that:

- The young person will understand the advice;
- The young person cannot be persuaded to tell his or her parents or allow the doctor to tell them that they are seeking contraceptive advice;
- The young person is likely to begin or continue having unprotected sex with or without contraceptive treatment; and
- The young person's physical or mental health is likely to suffer unless he or she receives contraceptive advice or treatment.

- The Provider will provide support and advice to clients accessing the service, including advice on the avoidance of pregnancy and sexually transmitted infections (STIs) through safer sex and condom use, advice on the use of regular contraceptive methods and provide onward signposting to services that provide long-term contraceptive methods and diagnosis and management of STIs.
- The Provider will provide verbal and written advice on the avoidance of STIs and the use of regular contraceptive methods, including advice on the use of condoms, to the client. This should be supplemented by signposting to a sexual health clinic that can provide treatment and further advice and care.
- The Provider will either offer a Chlamydia test or signpost the client to other Chlamydia testing services.
- The Provider must ensure that the consultation area used for provision of the service offers a sufficient level of privacy and safety.
- The accredited pharmacist (i.e. the Provider) will assess the need and suitability for a client to receive EHC, in line with the PGD. Where appropriate a supply will be made; where a supply of EHC is not appropriate, advice and referral to another source of assistance, if appropriate, will be provided.
- The Provider will ensure clients who have exceeded the time limit for EHC will be informed about the possibility
  of use of an intra-uterine contraceptive device (IUCD) and should be referred to a local service i.e. Nottingham University Hospitals Integrated Sexual Health Services as soon as possible.
- The Provider will apply inclusion and exclusion criteria during provision of the service. These criteria are detailed in the PGD.

## 4. Requirements for Pharmacy Participation

- The Provider will ensure that the only person who will provide the service will be the accredited pharmacist who will be appropriately trained in the operation of the service, including sensitive, client centred communication skills.
- The pharmacist providing the service will be required to attend any relevant training provided.
- The pharmacist providing the service must sign the PGD.
- The Provider (i.e. pharmacist contractor) has a duty to ensure that other pharmacists (e.g. locums) and staff involved in the provision of the service are aware of local protocols.
- The Provider must maintain appropriate records to ensure effective on-going service delivery and audit. Records
  will be confidential and the Provider must ensure that the handling, storage and release of data conforms both to
  the requirements of the Data Protection Act 2018, GDPR and any local provisions, protocols and policies. All
  information should be stored securely and for a length of time in line with local NHS record retention policies.
- The Provider must have access to Pharmoutcomes data management system for recording consultations and reporting activity.
- The Provider must ensure that relevant service information is retained for the purposes of audit and the claiming
  of payment. Records of provision of EHC must be maintained and submitted to Nottingham City Council (the
  Commissioner) if requested.
- The pharmacist providing the service must have completed the Centre for Postgraduate Education (CPPE) Declaration of Competency for "Emergency Contraception" prior to initiating the service. On completion a copy of the certificate must be forwarded to Nottingham City Council.
- Each pharmacy will ensure they are as young person friendly as possible. The Provider will ensure that professionals comply with *You're Welcome*' standards which set out the principles to help both commissioners and service providers to improve the suitability of NHS and non-NHS health services for young people. All Providers are required to provide evidence of an Enhanced DBS (Disclosure and Barring Service) check for all pharmacists and ensure that any other staff engaged in the delivery of services are appropriately checked by the Disclosure and Barring Service (DBS)

Training or review meetings for Providers may be arranged as required for exceptional or high priority issues. Pharmacists may attend these events as part of their 'Continuing Professional Development'.

Pharmacists should update, maintain and develop their capabilities according to their own identified learning needs.

- Continually review and be aware of relevant new and emerging guidance and recommendations and take the appropriate steps to assess and improve services to achieve current best practice.
- Ensure that appropriate professional standards are maintained, updated and validated through clinical supervision and provision of relevant training to support reflective practice and CPD.
- During the term of this specification fully co-operate in reviewing and improving/re-designing services at the request of the Commissioner, to include improving quality and performance monitoring.
